## **Resolution 2019 – 01** **Withdrawal from ESD**

WHEREAS, the Harney County School District is currently a member of the Harney Educational Service District Region XVII (HESD); and

WHEREAS, at the direction of the Board of Directors of Harney County School District #3, a study of the local service plan has been completed to assess potentially leaving HESD starting on July 1, 2019; and

WHEREAS, ORS 334.015(2) requires that *a school district board may choose to withdraw a school district from an education service district by an affirmative vote of two-thirds of the members of the school district board; and*

WHEREAS, ORS 334.015(3)(a) requires that *a school district board that chooses to withdraw a school district from the education service district must submit a notice of intent to withdraw to the board of directors of the education service district no later than November 1 of the year prior to the year in which the school district plans to withdraw from the education service district; and*

WHEREAS, as set forth in Resolution 2018-01, an affirmative vote of Board of Directors of Harney County School District #3 took place on October 9<sup>th</sup> to notify the HESD of an intent to withdraw with notice being sent to the HESD board of directors the following day; and

WHEREAS, ORS 334.015(3)(b) requires that *a school district board that submitted a notice of intent to withdraw as provided by paragraph (a) of this subsection must submit a notice of withdrawal to the board of directors of the education service district no later than March 1 of the year in which the school district plans to withdraw from the education service district; and*

WHEREAS, after considering the aforementioned items, the board supports by an affirmative vote of at least two-thirds of the members of the board in a regular board meeting held on January 16, 2019, as outlined by the signatures below, withdrawal from HESD for the 2019-2020 school year.

THEREFORE, BE IT RESOLVED by the board of directors that Harney County School District #3 will officially withdraw from Harney ESD commencing July 1, 2019, and a final notice be sent to the board of directors of the HESD by March 1, 2019, regarding this final decision to withdraw from the HESD effective July 1, 2019.
